Purpose of this privacy policy

2. This website does not store any Personal Data.

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

If you have contacted us via the Contract Us page your data will transfer different kinds of personal data about you which we have grouped together as follows:

- Identity Data includes first name, last name, or similar identifier, marital status, and title.
- Contact Data includes email address and telephone numbers if you provide these.

Sam Greer does not collect any Special Categories of Personal Data about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health, and genetic and biometric data). Nor any information is collected about criminal convictions and offences.

Please note: the only element of this website that collects data is via Google Analytics which uses a set of Cookies to collect information and report site usage statistics. It does not collect anything that is sensitive or that identifies the user. It only knows that one user is not the same as another user.

If you fail to provide personal data

Where we need to collect personal data by law, or under the terms of a contract we have with you, and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with legal services or carry out due diligence in accordance with our regulatory requirements). In this case, we may have to cancel your enquiry you have with us but we will notify you if this is the case at the time if permitted to do so by law.

Your legal rights

Under certain circumstances, you have rights under data protection laws in relation to your personal data (including but not limited to);

- Request transfer of your personal data
- · Right to withdraw consent to keep your personal data

What we may need from you

Time limit to respond

Sam Greer will try to respond to all legitimate requests within one month. Occasionally it could take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

LAWFUL BASIS

Performance of Contract means processing your data where it is necessary for the performance of a contract to which you are a party or to take steps at your request before entering into such a contract.

Comply with a legal obligation means processing your personal data where it is necessary for compliance with a legal obligation that we are subject to.

THIRD PARTIES
